

| 10 | The Department also drafted changes to the public           |  |  |  |  |
| 11 | records rules to eliminate redundancies and align with      |  |  |  |  |
| 12 | agency rules that are already in place.                     |  |  |  |  |
| 13 | The changes to implement the bills are in WAC               |  |  |  |  |
| 14 | 192-510-090: How will the Department determine the premium  |  |  |  |  |
| 15 | rate for each calendar year? And WAC 192-500-035,           |  |  |  |  |
| 16 | Interested Parties. The changes to public records rules     |  |  |  |  |
| 17 | are in WAC 192-810-010, Definitions; WAC 192-810-020,       |  |  |  |  |
| 18 | Purpose; and WAC 192-810-030, How do individuals and        |  |  |  |  |
| 19 | entities request records from the Department?               |  |  |  |  |
| 20 | The drafts that we will reviewing and discussing can        |  |  |  |  |

| 5  | MR. JASON BARRETT: All right, hearing none, we              |
| б  | will move on to our first rule, WAC 192-510-090. Senate     |
| 7  | Bill 5286 changed the calculation the Department must use   |
| 8  | to determine the paid Family and Medical Leave premium each |
| 9  | year. This rule is amended to establish the time period     |
| 10 | for which each calculation is applied based on the          |
| 11 | requirements of the bill in event of an appeal. The rule    |
| 12 | also clarifies that small business grants shall also be     |
| 13 | considered when determining agency expenditures with regard |
| 14 | to the new premium calculation.                             |
| 15 | Are there any questions or comments on this rule?           |
| 16 | (No response)   |
| 17 | MR. JASON BARRETT: Hearing none, we will move               |
| 18 | on to WAC 192-500-035. Senate Bill 5586 allows employers    |
| 19 | to access certain data points related to their employees'   |
| 20 | use of paid Family or Medical Leave. Specifically,          |
| 21 | employers are now permitted to know whether an employee     |
| 22 | applied for and received benefits for a particular week, as |
| 23 | well as the type of leave being taken. The rule specifies   |
| 24 | which employers are permitted to access this information    |
| 25 | and is intended to prevent other employers, who may be      |

| б  | 192-810-010. These changes refer to agency rules in WAC   |  |  |  |
| 7  | 192-02-020 and eliminate a redundancy. One subsection was |  |  |  |
| 8  | kept because it is specific to paid Family and Medical    |  |  |  |
| 9  | Leave. Are there any questions or comments on this rule?  |  |  |  |
| 10 | (No response).  |  |  |  |
| 11 | MR. JASON BARRETT: Next for discussion is WAC             |  |  |  |
| 12 | 192-810-020. Repealing this rule eliminates a redundancy  |  |  |  |
| 13 | because the purpose is already addressed in agency rules  |  |  |  |
| 14 | under WAC 192-02-010.                                     |  |  |  |
| 15 | Are there any questions or comments on this rule?         |  |  |  |
| 16 | (No response.)  |  |  |  |
| 17 | MR. JASON BARRETT: Last is WAC 192-810-030, How           |  |  |  |
| 18 | do individuals and entities request records from the      |  |  |  |
| 19 | Department? The changes refer to agency rules in Chapter  |  |  |  |
| 20 | 192-02 WAC and eliminate redundant information regarding  |  |  |  |
| 21 | how to request records. The information that is not       |  |  |  |
| 22 | changed or eliminated in this rule is specific to paid    |  |  |  |
| 23 | Family and Medical Leave privacy provisions found in RCW  |  |  |  |
| 24 | 50A.25.040. Are there any questions or comments on this   |  |  |  |
| 25 | rule?   |  |  |  |

| 11 | on something I don't understand. What is the minimum fee    |
| 12 | for   |
| 13 | MR. JASON BARRETT: Ma'am                                    |
| 14 | MS. SIXTA CASTILLO: self-employed people?                   |
| 15 | MR. JASON BARRETT: Ma'am, I'm sorry. Could you              |
| 16 | please introduce yourself and spell your name for our       |
| 17 | stenographer?   |
| 18 | MS. SIXTA CASTILLO: Yes. I'm sorry. My name                 |
| 19 | is Sixta Castillo. I was the one who earlier asked you a    |
| 20 | question. What would be the minimum for self-employed       |
| 21 | self-employers to pay for your own premium? You say that    |
| 22 | there's going to be a deduction for this? Do you have       |
| 23 | already the amount? Is that the same thing, the reduction   |
| 24 | for self-employed?  |
| 25 | MR. JASON BARRETT: Are you asking if any of                 |

| 3  | reduction in the premium? You mentioned that in the         |  |  |  |  |  |
| 4  | beginning, that there would a reduction in the premium for  |  |  |  |  |  |
| 5  | self-employed or self-employees.                            |  |  |  |  |  |
| 6  | MR. JASON BARRETT: So the premium that                      |  |  |  |  |  |
| 7  | self-employed individuals pay is identical to that of       |  |  |  |  |  |
| 8  | employees and employers. This doesn't really impact         |  |  |  |  |  |
| 9  | self-employed individuals any differently than it does      |  |  |  |  |  |
| 10 | standard employees. This rule just determines the math      |  |  |  |  |  |
| 11 | that the Department uses to calculate the premium, and then |  |  |  |  |  |
| 12 | we announce the premium publicly so that everyone knows     |  |  |  |  |  |
| 13 | what to pay. It basically affects everybody the same way,   |  |  |  |  |  |
| 14 | is what I'm saying.   |  |  |  |  |  |
| 15 | MS. SIXTA CASTILLO: Thank you.                              |  |  |  |  |  |
| 16 | MR. JASON BARRETT: Any other questions or                   |  |  |  |  |  |
| 17 | comments about any of the rules that we have discussed      |  |  |  |  |  |
