Purpose: The Employment Security Department is responsible for implementing the Paid Family and Medical Leave Program in accordance with Title 50A RCW. Rulemaking is being done on an ongoing basis. This rulemaking creates a new section as WAC 192-700-020 to provide guidance on when employers must continue health care benefits to an employee on paid family or medical leave under Title 50A RCW. The rulemaking also provides clarifying amendments to WAC 192-700-010.
